ORDER No. 53

of the Rector of the Nicolaus Copernicus University in Toruń

of 4 March 2025

**on fees for paid full-time studies in English at the Ludwik Rydygier Collegium Medicum
of the Nicolaus Copernicus University for each year of studies
for students commencing studies in the academic year 2025/2026**

Pursuant to § 1 sec. 2 of the Order no. 184 of the Rector of the NCU of 11 September 2020 on the rules for planning revenues and costs of part-time studies, paid full-time studies in English, studies for foreigners, post-graduate studies and other forms of education, as well as preparing estimates in the Bydgoszcz part of the Nicolaus Copernicus University in Toruń (NCU Legal Bulletin of 2020, item 305 as amended) in relation with art. 79 sec. 1 point 3 and art. 323 sec. 1 point 6 of the Act of 20 July 2018 on Higher Education and Science (Journal of Laws of 2022, item 1571 as amended).

it is ordered, as follows:

§ 1

For paid full-time studies in English conducted at NCU Collegium Medicum, hereinafter referred to as “studies in English”, the following charges are binding:

- 1) tuition fee (payment for classes covered by the Plan of Study);
- 2) payments related to the repetition of classes, resulting from unsatisfactory learning achievements, or to making up for curricular differences, and for classes not included in the Plan of Study;
- 3) additional payments for documents related to the course of study.

§ 2

The amount of tuition fee charged to students of studies in English commencing their studies in the academic year 2025/2026 and binding for the total duration of studies shall for each semester be as follows:

- 1) at the Faculty of Medicine, Medical programme:
 - a) winter semester – PLN 29.000,
 - b) summer semester – PLN 29.000;
- 2) at the Faculty of Health Sciences:
 - a) Physiotherapy:
 - winter semester – 16.000 PLN,
 - summer semester – 16.000 PLN,
 - b) Nursing:
 - winter semester – 17.000 PLN,
 - summer semester – 17.000 PLN;
- 3) at the Faculty of Pharmacy, Pharmacy:
 - a) winter semester – 17.000 PLN,
 - b) summer semester – 17.000 PLN.

§ 3

The amount referred to in § 1 sec. 1 point 2 charged to students of studies in English commencing their studies in the academic year 2025/2026 and binding for the total duration of the studies is PLN 60 per one hour of class instruction..

§ 4

1. The amounts referred to in § 1 sec. 1 point 3 charged to students of studies in English commencing their studies in the academic year 2025/2026 are determined by the provisions of generally applicable law.
2. The charges referred to in sec. 1 shall be incurred before the issuance of a document or its duplicate.

§ 5

The Order is effective as of 4 March 2025.
