DIRECTIVE No. 51

of the Rector of the Nicolaus Copernicus University in Toruń

of 15 April 2019

on fees for paid full-time studies in English at the Ludwik Rydygier Collegium Medicum of the Nicolaus Copernicus University for each year of studies for students commencing studies in the academic year 2019/2020

Pursuant to art. 79 sec. 1 clause 3. in relation to art. 323 sec. 1 clause 6 of the Act of 20 July 2018 on the Law of higher education and science (Dz. U. [Journal of Laws] of 2018, item 1668 as amended)

it is ordered as follows:

§ 1

- 1. For paid full-time studies in English conducted at NCU Collegium Medicum, hereinafter referred to as "studies in English", the following charges are binding:
 - 1) tuition fee (payment for classes covered by the Plan of Study);
 - 2) payments related to the repetition of the classes, resulting from unsatisfactory learning achievements, or to making up for curricular differences, and for classes not included in the Plan of Study;
 - 3) additional payments for documents related to the course of study.
- 2. Students qualified for studies in English who decide to participate in the preparatory course organized by NCU Collegium Medicum make an additional payment for that course.

§ 2

The amount of tuition fee charged to students of studies in English commencing their studies in the academic year 2019/2020 and binding for the total duration of studies shall for each semester be as follows:

- 1) at the Faculty of Medicine, Medical Programme (Medicine):
 - winter semester PLN 22,750.
 - summer semester PLN 22,750;
- 2) at the Faculty of Health Sciences:
 - a) Physiotherapy:
 - winter semester PLN 15,250,
 - summer semester PLN 15,250;
 - b) Nursing:
 - winter semester PLN 16,250,
 - summer semester PLN 16,250:
- 3) at the Faculty of Pharmacy, Laboratory Medicine:
 - winter semester PLN 10,250,
 - summer semester PLN 10,250.

The amounts referred to in § 1 sec. 1 clause 2 charged to students of studies in English commencing their studies in the academic year 2019/2020 and binding for the total duration of the studies is PLN 50 per one hour of class instruction.

§ 4

- 1. The amounts referred to in § 1 sec. 1 clause 3 charged to students of studies in English commencing their studies in the academic year 2019/2020 regulated by applicable provisions are as follows:
 - 1) issue of the electronic student ID card PLN 22,
 - 2) issue of a copy of the higher education diploma in English PLN 20,
 - 3) issue of a copy of the diploma supplement in English PLN 20,
 - 4) issue of a duplicate of:
 - a) the higher education diploma in English PLN 20,
 - b) the diploma supplement in English PLN 20,
 - c) student ID card 150 percent of the original document price.
- 2. The charges referred to in sec. 1 shall be incurred before the issue of a document or its duplicate.

§ 5

The fee for the preparatory course organized by NCU Collegium Medicum specified in § 1 sec. 2 is PLN 2,000.

§ 6

The Office of the Centre for Medical Education in English at NCU Collegium Medicum is obliged to:

- 1) inform the Vice-Bursar for Collegium Medicum about the number of persons participating in the preparatory course, no later than until 15 September preceding a given academic year;
- 2) provide the Vice-Bursar for Collegium Medicum with updated lists of students (data divided into individual years, faculties and programmes).

§ 7

With regard to issues not settled herein, respective regulations binding at the University shall be applicable.

§ 8

This Directive is effective as of 15 April 2019 and becomes legally effective as of 1 April 2019.
