RESOLUTION NO. 44

of the Senate of Nicolaus Copernicus University in Toruń

of 27 May 2025

amending Resolution No. 46 of the Senate of Nicolaus Copernicus University of 25 June 2024 on the conditions and procedure for recruitment of foreigners to the first year of studies in the academic year 2025/2026 at Nicolaus Copernicus University in Toruń

Pursuant to Article 70 (1-5) in relation to Article 323 of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2024, item 1571, as amended) and Articles 10 and 33 of the Act of 4 April 2025 on amendments to certain laws to eliminate irregularities in the visa system of the Republic of Poland (Journal of Laws of 2025, item 622)

the Senate resolves, as follows:

§ 1

Resolution No. 46 of the Senate of Nicolaus Copernicus University of 25 June 2024 on the conditions and procedure for recruitment of foreigners to the first year of studies in the academic year 2025/2026 at Nicolaus Copernicus University in Toruń (Legal Bulletin of Nicolaus Copernicus University of 2024, item 213, as amended), is amended as follows:

1) in § 18:

a) sec. 1 and 2 shall be replaced by the following:

- „1. Elements of the qualification procedure may include a high school certificate competition, a written examination, an oral examination, a qualification of artwork - portfolio, a self-presentation, a letter of motivation, a competition of grades from studies, a competition of grades from higher education diplomas.**
- 2. Written examination, oral examination, qualification of artwork - portfolio, self-presentation, are held through electronic communication tools that allow the identification of the candidate.”;**

b) sections 4 and 5 shall be added:

„4. In the case of candidates who hold:

- 1) certificates and other documents issued in the Polish education system;**
- 2) certificates issued by a school, certificates of graduation or other documents issued by an educational institution operating in the education system of a member state of the European Union, a member state of the Organization for Economic Cooperation and Development (OECD) or a member state of the European Free Trade Agreement (EFTA) - a party to the Agreement on the European Economic Area, entitling, respectively, to apply for admission to first-cycle studies, long-cycle studies or second-cycle studies in these countries.;**

- 3) **IB (International Baccalaureate) diplomas issued by the International Baccalaureate Organization in Geneva;**
- 4) **EB (European Baccalaureate) diplomas issued by the European Schools in accordance with the Convention on the Statute of the European Schools, drawn up in Luxembourg on 21 June 1994 (Journal of Laws of 2005, item 10);**
- 5) **school leaving certificates, diplomas of graduation or other documents issued by an educational institution abroad recognized by the country on whose territory or in whose educational system they operate, covered by the provisions of international agreements,**
the results of the competition of certificates or the competition of final diploma results constitute 100% of the total score possible to obtain in the course of the recruitment procedure, unless the detailed rules of recruitment for a particular field of study provide otherwise.
5. **With respect to foreign candidates applying for admission to first-cycle studies, long-cycle studies and second-cycle studies, the university shall verify the knowledge of the language in which the education is to be provided at the B2 level in accordance with the rules set forth in the Order No. 82 of the Rector of the University of Nicolaus Copernicus in Toruń of 26 March 2025 on the documents required from foreigners for admission to studies at the University of Nicolaus Copernicus in Toruń in the academic year 2025/2026 (Legal Bulletin of the University of Nicolaus Copernicus in Toruń, 2025, item 143) unless the rules for admission to a particular field of study provide for verification of language proficiency during the entrance exam.”**

2) annexes 1-16 are replaced by and constitute annexes to this resolution.

§ 2

The resolution becomes effective on 1 June 2025.
